"Community-driven Development: A Viable Approach to Poverty Reduction in Rural Burkina Faso" (March 2012)

By Niamboue Bado in *African Development Review* Abstract:

Various efforts by national governments, NGOs and international donors have shown limited success in reducing poverty in sub-Saharan Africa. As a result, poverty is still persistent in most households especially in rural areas. The persistence of poverty on the continent can be in part attributed to the top-down approach to development adopted by various poverty alleviation programs. This paper focuses on poverty reduction programs in Burkina Faso and argues that a community-driven approach to development and poverty reduction has the potential of lifting rural populations out of poverty trap.

The PRF has provided basic services to the poorest rural, remote communities in the country and built local capacity and institutions. Specifically, the fund has supported the increase in better access to roads, primary education, clean water and health care, which have all resulted in significant improvements in the quality of life for 650,000 beneficiaries, especially women and ethnic groups, in the most remote parts of the country.

"Urban Regeneration through the Use of Grants and Community Involvement: The Case of Penang, Malaysia" April 11

"Cities, People and The Economy" (2010) a joint publication between Khazanah Nasional and the World Bank showcases Penang (a state in north-west Malaysia) as a case study of regional development that aligns the symbiotic relationships between urban development, people and the economy. As part of its strategy toward urban transformation in Penang, public grants are used to catalyze urban change. The Grants supported initiatives involving industrial sector enhancement, human capital development programs and the

reorganization of cities, including major infrastructure projects. The presentation shared the experience and lessons learned from these initiatives led by Think City, a special purpose vehicle, established to support urban transformation. Think City is Malaysia's first urban regeneration initiative to build on community-led initiatives. The George Town Grants Program (GTGP), Think City's flagship project, which is still ongoing, has generated 120 projects since April 2010 based on small grants ranging from USD 5K - 50K.

"National Solidarity Program (NSP) and Local Governance in Afghanistan" April 18 By IEG, Afghanistan CMU and CDD CoP

NSP was created in 2003 by the Ministry of Rural Rehabilitation and Development to develop the ability of Afghan communities to make decisions affecting their lives and livelihoods. With the support of Facilitating Partners, communities elect their leaders to form voluntary Community Development Councils (CDCs), which have enabled them to undertake over 55,000 community-driven reconstruction and development projects in 29,000 communities in every province and district of Afghanistan. While there is little doubt that participatory development has helped to increase public confidence in the Government, the program is at a critical stage as it seeks to consolidate the gains in social capital by formalizing links between the CDCs and local government. The session was on NSP and Local Governance in Afghanistan to learn more about the policy options under consideration by the Afghan Government. The session also provided an opportunity to discuss possible ways forward for building on the achievements of NSP and moving toward institutional sustainability.

Regional Conference on CDD hosted by Asian Development Bank

The Asian Development Bank (ADB) held a Regional Conference on CDD on 31 January 2012 at their Headquarters in Manila. The conference provided an opportunity to share and distill lessons from four CDD country studies including CDD scale-up, and launch the CDD Learning Network to promote policy discussions, peer support, and knowledge sharing. It brought together around 90 participants from ADB's developing member countries, partner development agencies, academe and research institutes, and civil society organizations.
