Feature Story: Improving Education Quality in Indonesia's Poor Rural and Remote Areas

In Indonesia, high levels of teacher absenteeism have persisted, even with a government allowance to teachers in poor and remote areas. To address the challenge, in 2016, the World Bank began working with local communities to monitor and evaluate teacher performance, and then conducted an impact evaluation with support from the Government of Australia and USAID, as part of the KIAT Guru Pilot project. Initial results indicate that community satisfaction of teacher presence improved from 68 percent to 90 percent, and of teacher service



performance from 55 percent to 91 percent. As many CDD programs are working on community monitoring of vital services, like teacher service delivery, this <u>project</u> can provide policy recommendations for similar projects in other countries.

Video: In Steppe: Sustainable livelihoods in Mongolia's Westernmost Aimaq

Join our colleagues Jim Anderson, Ingo Wiederhofer, Erdene Badarch, and Badama Dondog, reporting directly from Bayan-Olgii, Mongolia's westernmost aimag (region). In these chilly scenes, they discuss the implementation of the <u>Third</u> <u>Sustainable Livelihoods Project</u>, which first began implementation in 2002, and is aimed at giving rural communities a greater role in government funding processes. They spoke on the project's objectives, specific challenges for social safeguards, and the use of incentives to improve transparency and participation.

Project Approval: CASA-1000 Community Support Project, Kyrgyz Republic

The <u>CASA-1000 Community Support Project</u>, Kyrgyz Republic was approved on April 10, 2018, by the World Bank's Board of Executive Directors, for US\$10 million IDA financing, and \$2 million CASA1000 Multi-Donor Trust Find. One of four CSPs in Central Asia and South Asia, associated with the CASA1000 electricity trade and transmission project, this CDD project will ensure that communities near the transmission line benefit in a direct and tangible way. Youth will play key roles in facilitation, awareness building, social accountability and financial management. The project will also be implemented through a partnership between the Community Development Agency and the Aga Khan Foundation.


Event: <u>Social Accountability in the Delivery of Social Protection: Improving Service Delivery and State-Society Relations</u> April 10, 2018

The Citizen Engagement CoP and the Global Partnership for Social Accountability held a lively session on a new report on how citizen engagement strengthens social protection and can contribute to better service delivery in social protection programs. The <u>report</u> discussed implications of this research for development programming in the social protection sector. Report: Growth for the Bottom 40 Percent

Boosting shared prosperity among the poorest 40 percent in developing countries is one of the World Bank Group's twin goals. A new IEG report assesses the World Bank's record in attaining that goal. It did so by monitoring of the geographic footprint of the projects, utilizing household surveys and geospatial data. The report showed that while the World Bank has operationalized this goal across GPs and across regions, it also noted that the World Bank needs to increase geographical monitoring of its projects to ensure it does focus on this bottom 40% target. Report: The Impact of Social Mobilization on Health Service Delivery and Health Outcomes

This paper examined the impact of citizen engagement and mobilization on service delivery. It analyzed a CDD program in rural Pakistan to assess the improvement in quality of public health services. The program not only organized women as

health workers, it also empowered them to identify important health issues. The program saw marked improvement in highly localized service delivery, but not in multi-village public programs – highlighting the importance of community involvement, enforcement, and monitoring for improving service delivery.
