Co-hosted by GFMA, ASIFMA, G20, Monetary Authority of Singapore (MAS) and the UN Environment Programme (UNEP), **G20 Green Finance Conference Singapore** was held in November 2017 in Singapore themed **'Making Markets Work for Green Finance'**.
