Private Sector Sessions- Summary

- **Global Financing Facility Webinar July 14th : Private Health Sector and COVID-19**
 - Governments partnering with private sector for essential services and products in pandemic- Myanmar, Ethiopia
 - Private sector delivery for both COVID and non-COVID essential health services
 - Importance of private health actors organizing themselves to dialog with health ministries
 - Challenges to public and private health sector working together, development partner support
 - Opportunities for integrating innovation as part of the new delivery models being created
- **AHFF July 16th: Modifications to Purchasing Agreements for COVID-19: Telemedicine**
 - Innovations in purchasing during the pandemic to increase health service delivery capacity
 - Public and private stakeholders who are using telemedicine, including public health insurance agency
 - India, Ghana, Nigeria, Brazil- defining reimbursement, setting quality standards, tradeoff between sophisticated technology versus more robust simpler systems
 - Telemedicine has improved health seeking behavior, including during COVID- service availability is key
 - Enabling infrastructure- private sector may not find investment viable in remote areas, more in urban with connectivity and electricity- reaching rural poor through public investment vs. purely private
