
Implementation Status and Key Decisions

The project has shown a good progress in terms of supporting expansion of targeted Ajutor Social program and introducing service delivery standards and new business model for local Social Assistance Departments (SADs), thus achieving two respective Disbursement-Linked Indicators (DLIs). Two more DLIs may be attained in the coming months as the Parliament adopts the amendment to the law#60 that envisages unification of transportation benefits for the disabled and as the Government approves establishing of an Agency for Administration of Social Support. The Ministry of Labor, Social Protection and Family committed to advance the decision-making on both pieces of legislation.

Furthermore, the Social Inspectorate is getting ready to carry out risk-based inspections. The first risk-based inspection campaign should be over in about six months, which would mark achievement of another DLI.


Not all new modules of the management information system—SAAIS—financed by the project appeared fully functional. The reasons are continued bugs in the software and non-utilization of modules by corresponding agencies. The MLSPF took necessary steps to finalize the modules and it should now ensure their utilization by corresponding agencies/units. After that, the Ministry will proceed to signing the contract for the second phase SAAIS extension.

The project delayed training for local social assistance staff pending creation of Agency for Administration of Social Support. Achieving the Agency's full functionality will take some time, the project should proceed with launching a comprehensive program of training based on the completed learning needs assessment.



Comments

The amount of overpayments of Ajutor Social Benefits was estimated at baseline at MDL6.6 million. In 2014, the amount of benefits irregularities identified by the Social Inspectorate reached MDL2.9 million that is 56 percent less than similar amount estimated at baseline. It is not possible to update this indicator at this point as the Social Inspectorate has not completed its annual reporting for 2015.


