Enabling policy and regulatory framework by local governments & implementation by local institutions like temple trusts

Financing through various mechanisms beyond government funding - own source revenue generation for operational sustainability is key

#### Actions to be taken by Govt. of Nepal



Develop enabling policy and regulatory framework to promote urban heritage conservation and regeneration following an area-wide approach

Community awareness generation on benefits of cultural heritage assets in terms of local economic development and livelihoods

Develop master plan for heritage conservation and urban regeneration in Kathmandu Valley in collaboration with other municipalities and relevant institutions.

Improve basic infrastructure and invest in physical conservation - focus on planning, implementation and management

Skill development initiatives for local cultural industry & encourage entrepreneurship

Institutional strengthening of municipalities for better planning, implementation and management of urban regeneration and cultural tourism
