Mumbai Metropolitan Region

The Mumbai Metropolitan region consists of Mumbai and its surrounding urbanising area extending over daily commuting distance. It covers 4355 sq.km which is nearly ten times larger than Mumbai city. MMR is composed of 17 big and small cities and about 950 villages. The 17 cities occupy 32% area of the region but housed 94 % of its population in 2011. About a fourth of its area is designated as forest and three river valleys offer a gifted hydrometric area.



 Needs.


Concept Plan for MMR - 2011

- Suggested new land reclamation for city expansion and restructuring of MMR into townships of 1000 ha. with pop. of 10 lakhs each.
- Recommended new Global Finance Centre in South Mumbai with 6 fringe & 5 city centres .
- Proposed centralised Integrated SWM, Coastal Zone Management and parks & recreation destinations.


Environmental Status Report of MMR (under preparation)

- The report is expected to generate a dynamic format for periodic data updation for various environmental parameters monitored by different agencies such as air quality, water quality, etc.


Regional Plan 1973




Regional Plan 1996




Existing Landuse Plan




Administrative Boundaries in MMR




Environmental Features




Area for Conservation & Development
